**APPLICATION:**

This is a submission on an application from **Hamachek Holdings Limited** who are seeking resource consent for a new commercial development for a multi-fuel energy centre and service hub at 160 Evenden Road, Twyford, which comprises the following:

- a four-lane dispensing forecourt for the truck stop, with the design futureproofed to provide for hydrogen dispensing;
- a facility for disposal of stock effluent from stock truck holding tanks;
- an eight-lane dispensing forecourt for the service station with associated 6m high, 468m<sup>2</sup> freestanding forecourt canopy;
- 4 EV charging stations, with the ability to provide further stations as and when demand increases;
- space for future hydrogen production and/or storage;
- LPG "Swappa" Bottle sales;
- a 300m<sup>2</sup> retail service area and shop;
- a 495m<sup>2</sup> café;
- a seasonal fruit shop comprising a courtyard encompassed by a 302m<sup>2</sup> "lean to" style shelter;
- a single 28m-wide, two-way combined entry/exit site access from Evenden Road.
